Old Business:

 Off-Campus Student Online Directory Update – Traci Kendall, Government and Community Relations (GCR), Mason

According to the Off Campus Student Services office, the Off Campus Handbook content is currently in a pdf document, but has not been put online due to a vacant communications officer position. They hope to get the handbook up on the website this summer.

• Established University Protocols for Off-Campus Student Complaints (handout) – Traci Kendall, GCR, Mason

The question was asked if community members could directly file a complaint about off-campus student behavior with Mason's Student Conduct Office. The answer is yes and the online form can be accessed at: <u>http://studentconduct.gmu.edu/contact-us/incident-reporting-form/</u>. This information has been added to the complaint protocol letter.

It was suggested that elected official office contact information be included in the letter, however since Mason students live in multiple jurisdictions, across multiple counties where a complaint might originate, the university will not be including individual contact information for elected official offices.

It was suggested that the opening paragraph of the letter could be revised to soften the tone.

New Business:

- Lightening Detection System Dave Farris, Director, Safety and Emergency Management, Environmental Health and Safety, Mason
 A presentation was made for a potential lightening detection alert system on Mason's west campus fields. There was a request by the City for additional information so they might consider it for City properties. Community members recommended that information be shared with adjacent HOAs.
- Fairfax County Water Construction Project/Traffic Re-route Frank Strike, Director, Project Management and Construction, Mason Facilities, and Traci Kammer Goldberg, P.E. Manager, Engineering, Fairfax Water

A presentation was made by Fairfax Water to alert FCAB members that there may be a potential traffic reroute onto University Drive during water transmission line construction. As plans get finalized they will make another presentation to the community at a Mason/Community Forum.

• Future Student Housing Feasibility Study – Beth Long, Associate Architect/Planner, Campus Planning, Mason

The University is undergoing a housing feasibility study to assess future housing needs for both undergraduate and graduate students. University enrollment projects were requested. Projects come out in mid-May.
